GRACE LUTHERAN CHURCH Semi-Annual Congregational Meeting January 23, 2022 12:45 pm

- I. **Call to Order:** Ron Goans called the meeting to order. Present (on zoom) were 37 screens. (It is assumed that several screens contained more than one member.)
- II. **Devotions:** Ron read a scripture from Bishop Strickland. The congregation participated in a responsive reading from Micah.
- III. Quorum Established? Yes. The assumption was at least 50 members for the 37 zoom screens.

IV. Proposed Budget 2022

- a. The proposed budget is \$335,506.
- b. There was a surplus at the end of 2021, so \$15K will be sent to the SE synod. Half of this money (\$7500) will complete the commitments for 2021 (\$30K total), and the other half will be the first commitment for 2022.
- c. The budget proposes a 5% raise for staff.
- d. Mike Lorenz moved to pass the budget. Donna Hoglund seconded. All on zoom were in favor. The motion passed.

V. Endowment Task Force

- a. This force oversees three endowments: GLC Endowment, Frances Johnson Endowment, and Raaen Scholarship fund.
- b. By acclimation, the congregation approved Steve Johnson to serve as head of the Endowment Task Force for another 3 years.
- VI. **Corner House** The house will be discussed at a future congregational meeting in 2-3 months.
- VII. **Approval of Minutes** Donna Hoglund moved for council to approve the minutes of this meeting. Stan Long seconded. All on zoom were in favor. The motion passed.
- VIII. Ron Goans closed the meeting with prayer. The meeting adjourned at 1:07 pm.

VI. Budget for 2023

- a. Donna Hoglund presented the draft budget for 2023. The current budget was used with the exception of moving \$2000 from the major property maintenance fund to the call committee fund.
- b. Larry Sparks mentioned that we are currently running \$13,000 in the red, so cuts may need to be made to the budget if this continues to the end of the year.
- c. There will be a meeting in November to finalize the budget.
- VII. **Food Pantry** Judy Joy mentioned that the food pantry needs plastic grocery bags that do not have holes or missing handles and are not too big or too small.

VIII. Vision Plan

- a. Nancy Munro presented the vision plan for 2023.
- b. Overarching goals = become an inviting church, provide outreach via relationships, and have more small groups.
- c. New mission = To love Jesus and help others love him through word and actions.
- d. New vision statement = We share God's love and grace to meet the needs of a diverse community.
- e. Big dream = Become a more diverse congregation in all respects, with emphasis on drawing in more families with children and youth; have more vibrant programs for children and youth.
- f. Mike Lorenz moved to accept the vision plan. Tim Lorenz seconded. All were in favor. The motion passed.
- IX. **Approval of Minutes** Mike Lorenz moved for council to approve the minutes of this meeting. Nancy Munro seconded. All were in favor. The motion passed.
- X. The meeting adjourned at 1:28 pm.

Pastor's Report

In my time here, I have presided at two funerals and four baptisms. We tended to an official joining of the church for a member, I made a visit to the hospital and have also done some visits with communion. I have spoken with lots of people either in person or on the phone, and sent out personal notes to those who I was told have been missing in action for a while, now. I've had one request to transfer to another church and two requests to transfer to Grace.

- Christmas was interesting with Christmas eve being on a Saturday and Christmas Day falling on Sunday. All worship services were very heart warming, and I enjoy working with our musicians David and Slade.

On the first Saturday of January, I gathered everyone together from the contemporary worship service so we might have some time to discuss things that should be changed, or stay the same or other ideas. It was well attended, and there was lively discussion that led to the possibility of changes. Stay tuned for that! I have been enjoying my time here, and the offer stands for you to stop in any time to say hello or unload the heaviness of your heart and everything in between.

President's Report

2021-2022 has been an exciting and productive period for members of Grace Lutheran Church (GLC)!

In many ways, this has been an eventful year and I would like to hit only a few highlights. Please look at the individual commission reports for additional details.

The church Council, Commissions and Pastor form the leadership team for GLC and I want to thank all of these individuals for their hard work during 2021-2022. The church Council at the beginning of my first term in October 2021 consisted of 9 members plus Pastor Larry Boudon. Council officers were: President, Ronald Goans; Vice President, Margaret Cumberland; and Secretary, Debra Stewart. Additional members of the GLC Council were: Ingrid Busch, April Fritts, Chris Gurecki, Mike Nichol, Paula Pope and Jackie Rylander. Nick Martin was an alternate member of Council. GLC staff included: Church Secretary, Pam Woodard; Music Director, Slade Trammell; Organist, David Ensley; and Sexton, Kim Lorenz. Appointed officers of the Congregation were: Treasurer, Larry Sparks, Financial Secretary, Janet Rawl, and Bookkeeper, Ken Joy.

The Commissions and their leaders form the backbone of GLC outreach to the community and to the world. Here is a list of GLC commissions and their chairs for 2021-2023:

The GLC 75th anniversary celebration was held on December 5, 2021 and this was a very successful celebration of ministry at GLC. We all want again to thank Pat Hope and her committee for their tireless work in putting together the memorial volume which was distributed to members of the congregation. The church in December, 2021 was in relatively good financial shape, with lower expenses than anticipated and with a small surplus. The church had also received an anonymous, non-designated gift of \$16,000, part of which Council designated to be used for purchase of two TV monitors for the Fellowship Hall. The Owl Pro video system was also approved for purchase. This will give additional audio and video capability for room 101 and should be helpful for Sunday School and for Bible Study.

The GLC 2022 budget was reviewed and was submitted to the congregation for approval at the congregational meeting on January 23, 2022. This meeting was held by Zoom due to issues with the current Covid pandemic. One significant component of the budget was a 5% cost of living salary addendum for our wonderful staff.

James Bauman prepared a very well documented report for Council on structural aspects of the house at 125 W. Gettysburg. His conclusion was that the house is structurally deficient and our best bet would be to demolish it and resurface the lot to direct water issues. A summary of issues was discussed for the house and for the vacant lot on Manhattan. The Property Use TF looked at all options, submitted their findings to Council, and it was decided to sell the lot and demolish the house as soon as feasible. Pamela Asher assisted us in selling the vacant lot for \$41,500 with net receipts to GLC of \$37,857.26 after fees and expenses. We all want to thank Pamela for assisting us through a very quick property transfer.

In late July 2022, Pr. Larry informed us that he had accepted a call to St. John's Lutheran Church in Griffin, Georgia. His last Sunday at Grace was on September 4, 2022. Being apart from his family has been difficult and this move will enable him to be with them full time in Decatur. I was in touch with Pr. Jonathan Hemphill at the SE Synod over several weeks and he assisted us in searching for an interim pastor. Pr. Paula Smith will be serving us as an interim pastor and we welcome her ministry here at GLC. Pastor Paula's installation was a joyous combined service with musical selections both traditional and contemporary.

The Grace Council in October, 2022 elected new members: Chris Bauman, Deborah Stewart, Ruth Smiley and Paul Gurecki, with Nick Martin and Judy Rosenberg serving as alternates. Council officers for the 2022-2023 year are: president Ronald Goans, vice president Mike Nichol, and secretary Jackie Rylander.

At the end of 2022, Treasurer Larry Sparks indicated expenses are less than anticipated leaving GLC in a positive financial balance. Donations have also been given to the Ukrainian families in Oak Ridge, which has been quite helpful to them. Money from the sale of the lot will help with maintenance of the church building after the house on the corner is demolished. A plan for replacement of upholstered furniture in the narthex and the pastor's office along with painting the office is in the process of being developed. Jackie Rylander and Ingrid Busch, along with Terry Domm have coordinated a plan for upgrading the narthex and office. In December, Paul Gurecki requested \$1900 for Stephen Ministry training and materials. Janet Rawl suggested raising the amount to \$2000 because the need for additional materials is ongoing.

Ruth Smiley has informed us of plans by the flower guild for a flower festival, proposed for April 15, 2023. Slade Trammell is coordinating music and Grace Writers will also be involved. This traditionally has been a beautiful event at GLC.

In conclusion, I want to share some thoughts from the September 25, 2022 congregational meeting. We have many things to be thankful for here at GLC. I began the meeting with a devotion considering some thoughts from Martin Luther on Psalm 1. His prayer of thanks on Psalm 1 is as follows:

O God, thanks and praise belong to You because You have given us Your Koly Word. Enlighten us by Your Koly Spirit to understand Your counsel of grace in Jesus Christ, to love Your Word, and to take delight in learning Your statutes and walking in Your Law. Bestow Your blessing and prosperity on the works of our hands in our Christian calling and all our conversation. Amen.

Music Director's Report

Chancel Choir returned to the choir loft and resumed singing unmasked in 2022. Though a number of members have not yet returned since COVID, we remain optimistic that this will begin to happen. We also remain committed to accommodating the health concerns of all involved. The level of music making in the midst of reduced numbers has been astonishing, and we will continue to raise the bar.

New Creation finished its initiative, begun in 2017, of introducing a new song every month. This has grown the set list of the 9 am service considerably. While a new song will not appear every month in the days ahead, we look forward to continuing to introduce more music on a regular basis.

Ringspiration continued its vital role of providing 11:15 am offertories, and various other pieces at various services, on a regular basis. Like all groups at Grace, Ringspiration looks forward to expanding in members now that life is returning to some sense of post-COVID normal. Unlike the other musical ensembles in the church, Ringspiration has never premiered a new work by a living composer. In 2023, we look forward to hearing the group premiere a piece written especially for them by the young composer Samuel Beall.

Treasurer's Annual Report for 2022

At the beginning of 2022 the congregation of Grace Lutheran Church approved a budget that was essentially a balanced budget. Our income ended up \$9263.85 less than was budgeted but our expenses were less than expected in several areas. For example, the \$5000 set aside each year for the Major Property Maintenance fund was taken from the sale of the Manhattan Ave property as mentioned below rather than from the operating budget. In addition, there were no significant major property maintenance issues this year. Therefore, we ended the year with a Net Income of \$14,487.25.

This cash amount does not include the congregation's Endowment Fund, the Frances Johnson Endowment Fund or the Raaen Scholarship Fund. These funds are invested separately, and the income produced each year goes toward their dedicated purposes.

The vacant lot at 132 Manhattan Ave was sold with Congregational approval and netted \$37,857.26. Funds have been set aside to demolish the house at 125 W Gettysburg Ave. Estimated cost of demolition is \$7500. Additionally, \$5000 of the proceeds were approved to be moved to the Major Property Maintenance fund rather than taking \$5000 from the general operating fund as is usually done to ease the burden on the operating funds. Funds were also approved for a new storage shed to house the riding lawnmower. The remainder of the funds are set aside for improvements (yet to be determined) on the property at 125 W Gettysburg Ave.

- The GLC Endowment Fund Task Force (EFTF) has invested the Frances Johnson Endowment and the GLC Endowment in the same mutual funds managed for GLC by Cumberland Wealth Management, via the Commonwealth Financial Network. The funds are invested in equity/ mutual funds in an effort to improve our rate of return.
- As per the By-laws within the GLC Constitution, the Raaen Scholarship Fund, are invested in Municipal Bonds and Mutual Funds at Cumberland Wealth Management, and is also overseen and managed by the EFTF.
- The EFTF scoping document was revised in 2017 and the language is now consistent for managing both the GLC and Frances Johnson Endowments
- Starting in 2023, for reporting purposes, the GLC & Frances Johnson Endowments will be consolidated/merged
- There were no recommendations for use of funds made by the EFTF. The baseline for capital growth (or loss) in 2022 is the combined fund balance of the Frances Johnson and the GLC Endowment accounts, shown at the end of 2022---i.e. \$130,054
- Grace By-laws specify the election of Endowment Fund TF members each January on staggered three-year terms. In January 2023 a team member must be elected by the congregation for a three-year term replacing Terry Domm whose term will have expired.

Administering Commission 2022 Annual Report

The Administering Commission is responsible for overseeing the care of that which has been entrusted to the congregation and managing the financial and business affairs of the congregation. Focus for the year was:

- Maintain and care for church property.
- Continue to upgrade the facilities.

Provide oversight of the financial health of the congregation.

The Commission members who served during 2022 were Ingrid Busch, Terry Domm, Steve Johnson, Claudia Lever, Mike Lorenz, Pat McMillan, and Rick Rawl.

Highlights of the 2022 activities are as follows:

Sale of Manhattan Avenue Property

Following approval at the May 2022 congregational meeting, the Commission oversaw the sale of the vacant lot owned by the church on Manhattan Avenue. Pam Asher was instrumental in handling the sale. Proceeds will be partially used to demolish the existing house at 125 Gettysburg Avenue and to replace an aging storage shed. Options for the new storage shed have been studied and the purchase has been approved.

125 Gettysburg Avenue

Following a Council study of potential uses for the former Contact house at 125 Gettysburg Avenue, the congregation voted to have it demolished. The Commission has contracted for the demolition of the house and the work is expected to occur in early 2023.

Renovation of Pastor's Office and the Narthex

A project to upgrade the furniture in the narthex and Pastor's office was initiated. Jackie Rylander, assisted by Janie Hiserote, led the process to select and purchase the new items. The new furniture is scheduled for delivery in January.

Virtual Service Enhancement

Technology enhancements in 2021 provided significant improvement in the visual and sound capability of the streamed services. Further improvements are being considered as virtual outreach is now considered a mission of the church.

A Technology Team supports efforts to provide and enhance the worship experience, inperson and remote. Tasks include manipulating the camera and sound during the services to optimize the viewing experience. Additional volunteers are needed. If you are interested in supporting this important function, please contact Terry Domm.

Computer System

A new computer for the food pantry was purchased and installed.

Raaen Scholarship

Hannah Mustaffa was awarded the Raaen scholarship again this year. She is attending the University of Tennessee at Knoxville.

Property

The Property Task Force, chaired by Rick Rawl, continues to keep the building and grounds in excellent shape. This group works diligently in the background, tending to a long and neverending list of projects to maintain, repair and improve the physical facilities. This important task force always welcomes new members. Tasks are typically of a short duration and can be worked at the participant's convenience.

That was done with the appointment of an interim pastor. A call committee was formed and installed. Stage 2 is Study and that's where the committee is right now. In this stage the committee works on the Mission Site Profile (MSP). The MSP is an overview of the congregation. When the MSP is complete, it will be approved by Council and sent to the Synod Office. The congregation will be asked for input for the MSP.

Stage 3 is Interviewing. Once the MSP has been approved, the Synod Office matches candidates based on the MSP. The candidates will be interviewed before one is chosen to present to the congregation. Stage 4 is the Call.

The committee hopes that the members of the congregation will take advantage of the meetings that will be set up to get input for the MSP. The committee also asks for prayers for discernment as we move forward in this process.

Nurturing provided a dinner and presented gifts to the students. This fall, Sheni Weber has met with Valerie Hansen and Pastor Paula for confirmation. Sheni's mentor is Lisa Sipes.

Donna Gurecki has coordinated and organized mentors for the confirmands. Mentors meet with their students on a monthly basis.

Stephen Ministry has four leaders: Stacey Garrick, Betty Anne Domm, Donna Gurecki and Paul Gurecki. There are nine trained Stephen Ministers in our congregation.

Nurturing provides devotional booklets "Christ in our Home" and other materials for seasons of Advent and Lent. We also provide family devotional materials for Advent and Lent to families. Birthday cards were sent to our children and youth on their birthdays.

We provided monthly educational materials to new birth families regarding growth and development and spiritual development from birth to three years. The curriculum is entitled

"Splash". To honor our new members and their families, Donna Gurecki embroidered a Cradle Roll banner, which is hanging in the Fellowship Hall.

Our fellowship activities have been very successful this year. The Frozen head picnic in April was attended by 20 people. Our barbecue in August was attended by 70 people. Thanksgiving dinner was attended by 65 people. It's wonderful to see that the congregation is ready to take part in these activities again.

Nurturing has also hosted receptions for the funerals of our members. We feel that this is an important ministry for our commission.

Our commission has provided dinner for students at Tyson House. Last spring, we took a meal to them in May. We plan to continue this ministry.

Grace's Greatest continues to meet. We thank Judy Joy for coordinating this group.

We are working toward getting some of our other fellowship groups up and going again. We thank all those who have kept our Stephen Ministry and education programs going. We also thank those who have coordinated and worked on fellowship events. We pray that our fellow members stay safe and well.

Proclaiming Commission 2022 Annual Report

The Proclaiming Commission is charged with overseeing all evangelism outreach activities for Grace Church, publicity, and communications. Grace publications now proudly proclaim Grace's updated mission statement, "LOVE JESUS AND HELP OTHERS LOVE HIM THROUGH WORD AND ACTION," and Grace's motto, "GRACE MAKES A WORLD OF DIFFERENCE." All Commissions and staff are urged to proclaim our Mission Statement and/or our motto, at every opportunity.

Members of the Commission for much of 2022 were Nancy Munro, Chair; Christy Gipson, Pat Hope; Chris Gurecki, Council Liaison; and Stan Long. The Commission's on-going outreach programs and specific events in 2022 are summarized below. Our activities continued to be significantly affected by the coronavirus pandemic and the shift to hybrid worship services and activities.

ALPHA: This is our premier way of reaching out to unchurched/formerly churched folks in the community in addition to people in the congregation, especially new participants. We offered a Winter 2022 Alpha course that was online only. Please pray for our Alpha program and be on the alert to invite people to our next Alpha course!

CAMPAIGN "SPREADING GRACE:" This campaign is on hold.

COMMUNICATIONS -- **INTERNAL**: Suggestions are welcome for additional enhancements to our internal communications.

COMMUNITY OUTREACH TEAM: A Community Outreach Team formed in October 2022 in order to plan events that will get Grace better known in the area and lead more people to our Grace location, hopefully resulting in visitors to worship and other activities. The Team carried out a very successful Trunk or Treat event on October 30. They also built and entered a float in the Oak Ridge Christmas parade. They have a number of events planned for 2023.

DIGITAL COMMUNICATIONS TEAM: Stan Long of our Digital Communications team had been the mainstay of updating the content of our digital displays; Pam Woodard has been helpful in updating the displays in 2022.

GRACE BROCHURES: We continue to update and use the 2015 Grace brochure that presents many of our ministries, programs, and opportunities for folks to get involved. It is used for visitors to the church plus Welcome to Neighborhood bags, etc. It was updated again for 2022 as some activities resumed and Pastor Larry left.

GRACE WRITERS: Writers of Grace has continued to flourish with leadership by Pat Hope. After the losses of Carol Oen and Cleva Marrow in 2018, the group set up a contest in their memory. With seed money from the two families and Grace Calendar sales, they shared a luncheon with the 2019 Flower Fest on April 27, 2019. Grace Writers gave out its awards then and had several winners read their work. They again held contests in 2020, 2021, and 2022 but announced awards via email at the end of the year due to the ongoing pandemic. The 2023 contest is now open for submissions. We get good publicity from *The Oak Ridger* for these contests. Participants include both Grace members and many others from the larger East Tennessee community and even out of state.

INVITING VISITORS: Proclaiming encourages all to continue to make Grace an "inviting" church as 70-85% of folks who visit churches in general come as a result of an invitation; we can significantly increase the number visiting by this means, even with online and in-person worship services.

THE LIGHT NEWSLETTER: An outstanding monthly newsletter is emailed to all members and paper copies are available to those without or not using a computer; they are included in visitor bags and Welcome to the Neighborhood bags. It is posted on our Grace website as well. Pat Hope has ably been our newletter editor in 2015 through 2022 and will be again in 2023 for which we are deeply appreciative. She has added many more photos and other new features such as book reviews and family recipes, plus more "Grace's Faces" features. The Light is a great read—take a look!

HOLY HIKES: Proclaiming will not pay for a membership in the Holy Hikes organization but will recruit volunteers to lead at least some Holy Hikes throughout the upcoming year.

HOSPITALITY FOR VISITORS: Welcome notes are normally written and sent to first-time visitors who are seeking a church home. Once we resumed in-person worship in 2021, we resumed this practice.

A Visitor Report on first-time visitors who are seeking a new church home is normally emailed to Proclaiming, other commission members, all Council members, and any members with responsibilities that would make it helpful. This is so they can be on the lookout to welcome such visitors if they come again, get acquainted, and invite them to activities of potential interest to them.

First-time visitor bags have been given after the worship services in the past; we hope to continue that.

The greeter program will resume soon now that we can have in person worship. Greeters will again be stationed at both front and back entrances. This enhances safety, helps those who might otherwise have difficulty opening our heavy exterior doors, and, for first time visitors, provides the opportunity to give directions to the sanctuary, nursery, Sunday School classes, or Jacob's Ladder as needed. Nancy Munro participated in 2017 in a group planning enhanced greeter and usher training; it is on hold.

INTERNATIONAL MINISTRY OUTREACH SUPPORT: Proclaiming Commission has provided significant support to the International Ministry Outreach goal adopted in May, 2013. This ministry's main program is our language program, consisting of both English for Speakers of Other Languages (ESOL) classes and Other Languages for Speakers of English (OLSE) classes. We have provided fliers for distribution and assisted with publicity within the congregation as well as in the community. Nancy Munro continues to coordinate the ESOL classes that started in November 2013. A Monday morning class has been a partnership with Altrusa International who provided \$500 per year for several years as well as volunteers. Kay Brookshire and Betty Anne Domm have reinstated a Monday morning class, now for two of our Ukrainian friends, assisted by Mary Jellison, also of Altrusa. Eunice Search teaches a beginner's class Monday-Thursday mornings. Dorothy DeVan teaches our evening classes; Joshua Williamson teaches Wednesday and Thursday a.m. classes. In addition to the ESOL classes, we had expanded what we now call OLSE (Other Languages for Speakers of English). Our weekly Spanish class was taught by one of our ESOL students for much of 2022 but is on hold as we look for a new teacher. Our Russian class is online, taught by our Russian ESOL student, Svetlana Popova. These classes are free and open to the community--tell your friends!

Deep appreciation goes to member volunteers Betty Anne Domm, Eunice Search, and Josh Williamson. Hearty appreciation also goes to friends of Grace who were ESOL volunteers in 2022, including Kay Brookshire and Dorothy DeVan, with Mary Jellison starting in late 2022

LITTLE FREE LIBRARY: Our Little Free Library has been a great success, especially with children's books being in continued high demand. It continues to thrive.

LIVING LUTHERAN GROUP SUBSCRIPTION: In 2016, Proclaiming arranged for a congregational group subscription to the print version of *Living Lutheran*, the magazine of the ELCA. *For 2022, we continued it for those who reimbursed the church at the group rate.* We will stop that in 2023.

MISSIONARY SPONSORSHIP: Grace sends an annual contribution of \$2000 to Pastor David Brondos for his ministry and supports him with prayer and annual Love Offerings. He is on the faculty of the only Spanish-language protestant Seminary in Mexico City, training mostly Mexican but also Central and South American citizens for the ministry. Pastor Brondos provides the Lutheran courses in this inter-denominational seminary and started online course offerings which have expanded the reach of the Seminary far beyond Mexico. The 2022 contribution was again \$1000 from the congregation budget, but that was augmented again by \$1000 from the Proclaiming budget.

NAME TAG SUNDAYS: Name tags had been provided to all members on occasional Sundays to promote name recognition and fellowship among members and visitors. We did these on all 5th Sundays and as needed otherwise. We hope to resume this when we have single services.

OUTREACH TO THE NEIGHBORHOOD: Outreach canvasses of the neighborhood were put on hold, including the caroling distribution of invitations to Advent and Christmas Eve services.

OUTREACH TO NEW RESIDENTS: Welcome-to-the-Neighborhood bags are placed in the front and back entrances for visitors and for any Grace person to take to new residents in their neighborhood and new colleagues or acquaintances in other avenues of life.

PET BLESSING: Instead of a full Pet Fest & Blessing bash, we did a blessing-only event that occurred in person on Sunday afternoon, October 2nd. Slade Trammell provided music both before and for the service. Judy Goans led the service and Crista Froeling assisted her with individual prayers. Much appreciation goes to Woodland School for again participating with a petoriented art show that was displayed in the Fellowship Hall later in the fall. Pam Williams again updated the Pet Fest website, Facebook presence and Twitter account and coordinated with Woodland School's art teacher. The proceeds of \$640 were augmented by \$1500 from the Proclaiming budget and will be distributed among 20 participating rescue groups.

POETRY PIE: This group meets monthly at Grace with coordination by Pat Hope. Several Grace members participate in addition to other non-Grace folks.

PUBLICITY: News releases on Grace activities are prepared and sent to print news media; Pat Hope did releases for the 2022 Writer's Contest, Pet Blessing in 2022, for the 75th Anniversary/Thanksgiving dinner, and for the Grace Writers' Group 2023 Writer's Contest.

PHOTOGRAPHY: A team of photographers captures photos of most events for publicity and historical purposes. Photographers in 2022 in addition to Pat Hope and Stan Long included Laura Boudon, Gloria Caton, Christy Gipson, Donna Gurecki, Ruth Smiley, Marla Weber, and Pam Woodard. Others are welcome to help anytime!

SOCIAL MEDIA TEAM: Our Website Team has morphed into a Social Media Team, now including Pam Williams plus Stan Long. Stacey Garrick, Ruth Smiley, Tim Lorenz, Chelsea Martin and Emilie Damos came on board as of late 2022 after Laura Boudon handed off our Facebook and Instagram presence in the early fall. After revamping the website in 2015 and adding a Pet Fest Website, Pam has had the ongoing role of webservant, keeping all updated. Pam has also done a website for the Writers of Grace group, and FaceBook and Twitter accounts for Pet Fest and Blessing and a *Twitter account* for Grace; we discontinued the latter in November due to lack of use. The congregation is encouraged to make our website (graceoakridge.org) your default page for your browser. Virtually all visitors find us online before attending services. Remember to give information to Stacey and those posting to FaceBook for posting on upcoming activities. Photos are needed as our Instagram is now linked to our Facebook page and requires photos.

TAPE MINISTRY: We thank Ingrid Busch for recording the worship service each Sunday and burning CDs with recordings. The audio of each sermon is uploaded to our website. Currently a CD is mailed to those members who don't have internet access. The CDs continue to be in an organized storage pouch at the entryway end of the narthex for those who wish to take one to an ill or homebound family member or friend.

TYSON HOUSE SUPPORT TEAM: Support for Tyson House continued with a group providing a meal in August, 2022.

VIDEOGRAPHY TEAM: Ingrid Busch coordinates the teams of camera operators for both services. Ingrid also handles sound for both the 9 a.m. and 11:15 services. The videos are posted on our Facebook page and linked to the website. Steve Johnson and Debra Stewart have been added to the volunteers who handle the cameras. Ingrid Busch has been instrumental in getting the new systems up and running. *This team is especially important as Grace intends to continue with hybrid services (both on line and in person) long term.*

Serving Commission 2022 Annual Report

The Serving Commission at Grace oversees tasks that serve both the local and world communities.

The **Food Pantry** celebrated 35 years of continuous operation in July by constructing a toilet paper tree. Our pantry is the only one to give it and has become known as "the toilet paper pantry"

Inflation has hit the food pantry just as the client load is increasing and the funds are running low. The Food Pantry served an average of 180 families a month in 2022, up considerably from 108 last year. However, in the last three months, we served 200 families a month. The high was 83 on the Friday before Thanksgiving and the low was 21 on Dec. 30th. Some families come once a month and we had a lot of new families. In 2022, food from Second Harvest cost \$27,587. Yes, their food has gone up, too. Supplies such as toilet paper, bath soap, laundry soap, and diapers were purchased at local stores for \$9890. We deliver baskets of food to the client's cars and it works much better than having them come in.

In addition to the generous contributions from church members. other churches donated food, money and volunteer hours. Thank you to Judy Joy and all the volunteers who faithfully serve on Wednesdays and Fridays.

Holiday Baskets were distributed using the procedures developed during the pandemic. Holiday Baskets is a group effort, made possible by many church members. April Fritts works with the Family Resource Center to identify families needing assistance in our community, as well as some people who are added to the list by our church and/or individual members. Baskets were given to 26 families at both Thanksgiving and Christmas.

The Holiday Basket Fund is replenished with Love offerings and is separate from the Food Pantry Fund. The fund is currently near empty, so there will be a special effort made to collect funds for Easter Baskets from the February Love Offering.

The **Angel Tree** ministry served 58 children. Each child had two angels, one for clothes and one for toys. Angel Tree gifts were taken to the vehicles when the families picked up their Christmas baskets. Ingrid Busch and her elves did a great job. Ingrid once again was approved for a Thrivant Action Team grant to help cover costs.

Grace Lutheran works together with Kern Methodist to operate the **Ecumenical Storehouse** on a rotating basis with 10 other congregations. The Storehouse is still operating under procedures set up under the pandemic where the clients have limited entry. New volunteers from Grace have joined the effort this year and they are much appreciated. Barbara Storaasli represents Grace on the Storehouse board.

The Serving Commission is the liaison for the **Boy Scout** troop that meets at Grace. Internationally, Grace supports the **Lutheran World Relief Equal Exchange Project** by selling coffee, tea, and coffee. Items for sale are in the kiosk located in the main entry. Thank you to Judy McMillian for leading this effort.

Vicki Quraishi submitted the following about the work of the Blanket Workshop:

2022 presented several opportunities for Grace's Blanket Workshop to dig into our commitment to provide handmade quilts for needs of people both locally and globally. COVID-19 and the weather seemed to challenge us frequently. Our group was finally able to meet on March 3rd.

We also had taken on a Special Project for our 50th Anniversary; to dedicate in March, a full-sized quilt to honor the 117 women and men, who had inspired us over these fifty years. We joyfully completed this special quilt; it was dedicated in March, and it hangs in our Narthex.

Our group of 14 individuals worked hard to design and assemble quilts and amassed 353 hours thru August. As a result, we delivered 35 much needed quilts and 8 large School Kits to the LWR collection site in Greeneville, TN. We averaged 4-5 workers for each quilting session in those six months. In the final 4 months of the year, we invested another 168 hours busily working on more quilts for 2023! As in the past, we donated to the LWR Quilt & Shipping Fund to help with the increase in costs.

We welcome others to join us at any time and you don't need to sew! We need individuals with creative ideas; those who can cut a straight line and others who can tie a knot. We meet the first, third and fifth Thursday at 10 am to 2pm. We bring our lunches and have brief devotions at noontime. We'd love to see YOU there!

Stewarding Commission Annual Report 2022

The Stewarding Commission and congregation continued use of YouTube for watching services remotely and use of Zoom to meet online to conduct the business and continue support of the ministries of the congregation. Many of the activities of the congregation continued to use a hybrid mode to allow those for whom health risks are high to continue participating at home with those who are able to meet in person. Success with this adjustment is an example of "Creating Opportunities," the theme chosen for the 2022 pledging campaign and a theme being used for stories celebrating the ministries of the congregation.

Throughout the year the commission looked into implementing an online giving option. Local churches were contacted to find out what online software is being used and their experiences with them. To support this effort, two documents were prepared. Chuck Thompson prepared a document with an initial list of requirements for online giving software and what is needed to integrate it into the current financial accounting arrangement. John Munro prepared the second document that lays out a path for making a transition from the current accounting process to one including an online giving option.

Vanco is a leading online giving system recommended by the ELCA. Vanco has given several presentations at various times to the Stewarding Commission. The possibility of linking online giving to specific ministries of the congregation was suggested during the presentations. This suggestion would work well with providing links to ministries with associated sharing abundance stories. This is a possibility that the Stewarding Commission is pursuing regardless of the online giving software chosen for Grace to use. The Vanco system can also be integrated with many financial management software packages such as Church Windows which is currently used by Janet. Vanco also provides templates and example descriptions of ministries like the food pantry that allow someone who wants to make a contribution see what ministries the congregation supports. Until arrangements can be made for online giving, sharing abundance stories on the church's web site will provide instructions for giving through the church office. A Sharing Abundance Stories Spreadsheet is being used to track preparation and use of stories. Stories are solicited in weekly announcements and published in the Light.

Margaret Cumberland found a basic plan on caring for creation from "Lutherans Restoring Creation" that she distributed for the Commission to review. She presented some ideas for a task force (Green Team) to begin work on that call attention to ways to care for creation, including activities for the congregation. Efforts were initiated to provide a "Tip for the Week" on ways to show care for creation.

A thank you letter was written and mailed to all who submitted pledges and turned in Discipleship Opportunities forms for last year. This year's stewardship campaign materials were mailed out to members of the congregation built on what was developed for last year's campaign continuing the emphasis on sharing abundance but with changes to focus on this year's theme: Creating Opportunities. Efforts continued with Discipleship Opportunities forms to find out what interests and skills members of the congregation have beyond the usual time and talent responses focusing on needs of the congregation.

It was proposed to Church Council during the October Council meeting that the name "Stewarding Commission" be changed to "Sharing Abundance Commission." Council is taking this request under consideration.

Worshipping Commission Annual Report 2022

The Worshipping Commission is chaired by Judy Goans. Margaret Cumberland schedules the Young Peoples' Messages for both services. Barbara Sparks schedules worship assistants/ liturgists and readers for the traditional services, while worship leaders for contemporary services are scheduled by Donna Gurecki. Beginning in early 2022, both the contemporary and traditional services are streamed.

Altar Guild

Kathy Olsen briefly took charge of the Altar Guild, and Ruth Smiley has now assumed responsibility as chair. Presently April Fritts, Janet Rawl, Kathy Olsen, Linda Long, and Judy Rosenberg serve on the Altar Guild.

Flowers

Sign up for flower calendar and distribution will begin in January 2023. Sign up for poinsettias was posted in December. Announcement for cheering members with flowers will be made as well as assisting altar guild with distribution within a day or two of Sunday.

Advent and Christmas 2022

Advent evening services were based on music by Marty Haugen. Services were led by Pastor Larry Boudon with participation by Paul Gurecki. Services were well-received. The peaceful nature of these services provided a good contrast with the stress and busyness of Christmas preparations.

Lighting of the Advent candles was observed without additional music or recitations. It was incorporated into the Young People's Messages, and children helped light the candles.

The Christmas cantata was performed on December 18, 2022, and was well received. Words were easily understood even though the choir was masked.

Decorating the tall tree created some safety concerns so a smaller tree was purchased.

The narthex was decorated with the usual wreaths plus multicultural display of nativity scenes and angels. Entitled, Tables of Stables and Choirs of Angels, the display included a range of creches and angels ranging from traditional European Renaissance angels to angels that appeared to be Caribbean or African and creche sets from Uganda to the Andes. The multicultural theme was intended to remind us of the universal importance of the Incarnation.

Christmas Eve services had larger than expected in-person attendance - 84 for the early service at 4 p.m. and about 80 for the 9 p.m. service. The variety and number of musical offerings were well received.

One concern was that singers could not be heard during the contemporary service. This was addressed by setting up additional microphones.

Lent and Easter

An Ash Wednesday service was held on Wednesday, March 2 at 6:15 p.m. Packets of ashes were distributed at the service and also ahead of time for those who watched the service at home. Lenten Taizé services were held at 6:15 p.m. each Wednesday.

In an effort to involve children, Judy Goans prepared a series of short skits to be used in the Young People's Messages each Sunday. Some children participated in delivering these skits, which presented the Gospel reading as though it were a news story. However, other children were reluctant to participate in the skits, which were instead read by adults. Skit participants included Bella and Beverly Bauman, Kyle Conti, Donna Gurecki, Chelsea Martin, Judy Joy, Claudia Lever, Lisa Sipes, and Rick and Janet Rawl.

Palms were distributed on Palm Sunday.

During Holy Week, Grace held Maundy Thursday and Good Friday evening services at 6:30. An Easter Sunrise service was held at 7 am in addition to regularly scheduled contemporary and traditional services.

A visual feature was added this season: the tomb with a roll away stone. Thanks are due to James Bauman for reinforcing a commercially-available cardboard version, making it more stable and durable, and for creating an actual place for Jesus to lie, not just an image on the back wall. A puppet Jesus, purchased for use in the Young People's message, was laid in the tomb by one of the children and the tomb closed, and on Easter, the stone was rolled away to reveal the empty tomb. This visual display was well-received and is available for future use.

Other Events and Actions

Reformation Sunday was observed on October 31 with a service of Lessons and Carols authored by David Ensley. A number of banners were procured to celebrate the Reformation. These were funded by a private donation.

All Saints Sunday was observed on November 6 with the reading of names of the departed, accompanied by the sounding of a bell. Members of the congregation were invited to light a candle in memory of departed loved ones.

Pastor Paula Smith was installed as interim pastor at a single service on November 20, 2022. Pastor Jonathan Hemphill from the Southeastern Synod preached.

Beginning in September, several **changes were made to the traditional worship service**. These included shifting announcements to 11:15 a.m., followed by the Prelude; reinserting the creeds; chanting the Kyrie; adding an offering prayer after "Let the Vineyards," and a return to the historic wording of the Lord's Prayer. Readers with difficulty with steps may participate from floor level. The choir will process out during the final hymn. Also, it was determined to include individual names of members in the prayer for healing.

Training for young people who may want to participate as crucifer or acolyte was held on October 21, 2022. Candace Yugo of Nurturing helped organize the training. Robert Goans prepared two small processional crosses suitable for younger children to carry. These processional crosses incorporate hand-carved Ethiopian crosses. Several younger people have now volunteered as crucifer or acolyte.

Considering the need for contemplation before the traditional service, the Commission recommends announcing the **need for quiet in the narthex** beginning at 11:00.

Budget

The Worshipping Commission's budget for 2022 was \$5,000.00, of which the Commission requested reimbursements for \$4,640.00. About 60% of the budget goes to pay for licensing fees, with most of the rest used for communion supplies.
